Position Summary

The School of Agriculture, Food and Ecosystem Sciences is searching for an outstanding academic to fill a new position in our urban horticulture teaching programs. In this role you will foster new opportunities in teaching and research of either i) horticultural approaches in community food production and urban greening for social and environment benefits, or ii) garden and urban landscape design with a focus on plant-led design for social and environmental benefits. These opportunities will be leveraged across the School, Faculty and University, as well as externally in collaboration with industry, government and NGO partners. You will contribute to teaching excellence in urban horticulture and interdisciplinary subject areas at both undergraduate and postgraduate levels. You will also make significant contributions to research in urban horticulture, establishing a research program that advances academic knowledge and benefits the broader community through effective engagement and outreach activities.

The successful applicant will be based at the Burnley Campus only 5 km from Melbourne's CBD. Burnley has a century old tradition of horticultural excellence and is a dynamic multidisciplinary campus focusing on urban horticulture, green infrastructure, urban ecology, ecohydrology, and forest science with outstanding research facilities.

We encourage applicants from under-represented groups, including Aboriginal and Torres Strait Islander people. To allow us to consider performance relative to opportunity, we also invite applicants to provide a brief statement (up to 1 page) that describes circumstances that may have affected their career development or progression, including career interruptions or delays, periods of part time work, or forms of bias they have experienced.

1. Key Responsibilities

As with all positions, career achievements will be interpreted relative to opportunity, including career disruptions due to caring responsibilities, time in industry, illness etc.

The School operates from four campuses (Parkville, Burnley, Dookie, and Creswick), and this position is primarily based at the Burnley campus. The appointee may be requested from time to time to engage in activities at other campuses, necessitating intercampus travel and participation in activities based at those campuses, or other locations, such as field trips.

A Lecturer at Level B is expected to make contributions to the teaching effort of the institution and to carry out activities to maintain and develop his/her scholarly, research, and/or professional activities relevant to the profession or discipline. Specific duties:

1.1 EDUCATION & LEARNING

The appointee will be expected to:

Work closely with the Urban Horticulture teaching team to deliver undergraduate and postgraduate horticulture and urban greening subjects.

- Design and develop curriculum in either i) horticultural for community food production and urban greening for social and environment benefits, or ii) garden and urban landscape design with a focus on plant-led design for social and environmental benefits.
- Prepare and delivery lectures, tutorials, practicals and seminars as appropriate.
- Provide academic mentoring and assistance to students.
- Coordinate and run student field trips.
- Undertake administrative tasks associated with the subjects taught, including consultation with students, marking, assessment, preparation of resources for tutorials, practicals and fieldtrips.
- Contribute to subject coordination including the supervision of sessional tutors.
- Supervise honours and masters coursework students as required, to ensure the timely completion of their research projects.

1.2 RESEARCH

The appointee will be expected to:

- Conduct internationally competitive research in the urban horticulture discipline.
- Contribute to and publish academic papers and other scholarly outputs to a high academic standard in accordance with the research expectations of the University of Melbourne.
- Contribute to the preparation, or where appropriate individual preparation, of research proposal submissions to internal or external funding bodies as relevant.
- Actively participate in research seminars, and national and international conferences.
- Supervise graduate research students as required, to ensure the timely completion of their research.
- Contribute to developing networks within the discipline and with other universities, institutions and communities, both nationally and internationally, to support collaboration.
- Present research to the public to elevate public awareness of educational and scientific developments and promote critical enquiry and public debate within the community.
- Undertake administrative functions and obligations primarily connected with the staff member's area of research.

The appointee will be expected to:

- Actively participate at School meetings and contribute to planning activities or committee work to support capacity building in the School/discipline.
- Be involved in professional activity in the discipline.

- Completion of a PhD in urban horticulture, urban ecology, urban design, landscape architecture or a related discipline
- Demonstrated experience in urban horticulture and expertise in one or more of the following areas: urban food production, plant propagation or urban planting and establishment, plant selection approaches for urban greening or garden design, garden and landscape design and graphics.
- Demonstrated experience, relative to opportunity, in developing engaging undergraduate and/or postgraduate teaching programs.
- A demonstrated aptitude for independent research, with a sound publication record in relevant areas, commensurate with experience and relative to opportunity.
- Experience in supervising research students, relative to opportunity.
- Excellent interpersonal and communication skills including the ability to build positive, professional relationships with staff, collaborators and students.
- Demonstrated ability to work collaboratively and collegially within a diverse workforce.
