The SA Pharmacy Assistant Candidate Pool is now open to applicants who are interest in joining SA Pharmacy for short term employment.

What types of roles are available through the Candidate Pool?

Roles that will be offered through the candidate pool are short term and contractual in nature for vacancies of up to 12 months. They may be part time or full time. Most commonly initial contracts are for 1-3 months only. If you do not have hospital pharmacy experience it would be unlikely for you to be offered a longer contract initially.

As part of your application process it is important that you only preference sites that you would be willing to work and the days of the week that you are available to work.

How do I apply to the SA Pharmacy Candidate Pool?

What is the application timeline?

Applications will be accepted on a continuing basis. Applicants who have registered their interest will be notified via email if they are to be invited for further assessment or if a vacancy becomes available suitable to their skills and preferences.

What will I need when applying?

- A current resume/curriculum vitae to assist in populating the application.
- Contact details (email and telephone) of three current referees.
- Visa/passport details (if you are not a permanent Australian resident).
- The sites you are available to work at
- The shifts early, normal and late that you are available to work
- The days of the week you are available to work
- The shortest duration of contract you will accept.

Other information collected during this process includes immunisation status and criminal history screening clearances (aged and working with children).

What classification will I be considered for?

The Assistant Candidate Pool will be used to offer positions at the AHA1 and AHA2 level. The classification of employment will depend on qualifications and experience in accordance with the enterprise agreement/SA Pharmacy position descriptors/work level definitions. An applicant would be appointed at an AHA1 level, unless they possess a relevant certificate III or higher or have 6 months recent experience in SA Pharmacy, in which case they would be appointed at the AHA2 level.

How are applicants selected?

All applications will be assessed against predetermined criteria and suitable candidates may be invited to an interview. It is anticipated that referees will be contacted so please ensure you maintain up to date details of relevant referees and that you have sought their permission for SA Pharmacy to contact them.

How will I receive further communication from SA Pharmacy?

Most correspondence will be via email so please check your email on a regular basis. It is your responsibility to ensure you check your emails so you do not miss any information.

What happens once I am placed into the successful Candidate Pool?

The information collected during the application process (see above) will be shared with SA Pharmacy staff who are responsible for recruitment at each SA Pharmacy site. They will contact you directly by phone when they have a position that you have indicated you are interested in.
