POSITION PURPOSE

Education-focused staff (as a subset of the Teaching and Research category of employment) at Monash are a vitally important category of the academy who focus on and contribute to the innovation of education, and who lead the design and delivery of education at the University.

A Senior Lecturer (education-focused) is expected to make significant contributions to the teaching effort within the University and Faculty, especially in the core law units in the curriculum, such as administrative law, company law, contracts, criminal law, property law, trusts, equity, intellectual property law, and Litigation & Dispute Resolution. They are expected to play a major role in leadership of educational design and delivery and towards adopting evidence-informed approaches to practice.

KEY RESPONSIBILITIES

Level C (education-focused) academics must demonstrate abilities to lead and innovate in educational practice and design, and must engage in scholarly activity related to education practice in their field.

Specific duties required of a Level C (education-focused) academic may include:

- 1. Design, delivery and evaluation of a range of teaching activities which engage students actively and enable the effective delivery of learning outcomes (across activities such as tutorials, practical classes, demonstrations, workshops, and clinical sessions)
- 2. Leadership in legal education and curriculum development, *particularly in the law core curriculum*
- 3. Consulting with students and demonstrating a student-centred orientation
- **4.** Course coordination, including offering guidance to assistant lecturers and supervision of sessional staff in teaching unit/s if required
- 5. Design and implementation of diversified and valid assessments
- 6. Marking and providing constructive feedback within and across units
- 7. Leading teaching teams to implement consistent and effective marking and constructive feedback practices
- 8. Leading unit/course development and/ or team teaching and undertake relevant unit administration requirements as required
- **9.** Systematically collection of and responding to student feedback to review and improve units and individual and/ or team teaching practice
- **10.** Scholarly activity and/ or generation of research outputs which demonstrate an informed and advanced understanding of educational practice in their field
- 11. Supervision in Honours and Research Higher Degree individually or as part of a team
- **12.** Participation in and leadership of Faculty administrative matters, including committees, course program management and other administrative roles as required
- 13. Other duties as directed from time to time

KEY SELECTION CRITERIA

Education/Qualifications

- 1. The appointee will have:
 - Qualifications and/or experience recognised by the University as appropriate for the relevant discipline area. A position at this level will normally require a doctoral qualification or equivalent research, teaching or practice experience.

Knowledge and Skills

- 2. Ability to teach effectively in a manner that motivates, engages and inspires students to learn
- 3. Demonstrated record of teaching and assessment experience in law curriculum units in a tertiary environment, particularly in the core curriculum (such as: Administrative Law, Company Law, Contracts, Criminal Law, Property Law, Trusts, Equity, Intellectual Property Law, and Litigation & Dispute Resolution)
- 4. Demonstrated experience in curriculum development in law curriculum units in a tertiary environment, particularly in the core curriculum
- 5. Evidence of scholarly activity and/ or research which informs education practice in their field
- 6. Knowledge of industry needs and employability requirements related to the teaching field
- 7. Team leadership experience
- 8. Strong interpersonal skills and demonstrated ability to work independently and as part of a team
- **9.** Excellent planning and organisational skills, including the ability to undertake continuous improvement processes and comply with organisational policies and procedures
- **10.** Experience in the higher education sector and knowledge of the structure and operations of university learning, teaching and research
