Position Purpose

This position will coordinate Council's pest management teams to deliver of programs, projects and initiatives that enhance the natural environment, protect local fauna and flora and reduce the region's biosecurity and vector risks. This position is also responsible for providing contemporary and practical responses to complex environmental issues, including working in collaboration with Government agencies and the community to deliver positive environmental outcomes.

Key Responsibilities and Outcomes

Operational

As a senior member of the Environmental Services Department, you will:

- Provide leadership to multiple teams of officers, delivering positive environmental outcomes for Council and the community.
- Act as the principal lead in the provision of advice in response to complex pest management issues which impact the community's amenity and the regions aquatic and terrestrial ecosystems.
- Initiate and retain strong relationships with government agencies, landowners and multiple community groups, representing Council to ensure that technological advancements in pest management techniques are optimised, quality customer service is delivered, and environmental outcomes are achieved.
- Coordinate the planning and delivery of a suite of diverse pest management and biosecurity programs, projects and initiatives, including Council's Biosecurity Plan, mosquito management program and invasive pest animal and plant initiatives.
- Ensure Council's pest management programs and projects comply with legislative requirements, including submission of reports to the Queensland Government, as required.
- Develop officer capabilities across the wider Environmental Services department, through strong adherence to a range of workforce management activities which deliver high team performance.
- Manage the Pest Management budget within the delegations for this position.
- Demonstrate extensive knowledge of governance and risk management principles and practices.
