In 2013 ACU developed a research intensification strategy designed to achieve excellence in a selected number of areas of strategic priority. Research excellence is measured through external assessments such as the Excellence in Research for Australia (ERA) outcomes and world university rankings (Shanghai ARWU; Times Higher Education; CWTS Leiden), particularly subject rankings where available. The outcome of the research intensification strategy has been a remarkable transformation in the research standing of the University. In the 2020 Times Higher Education World University Rankings, ACU has risen to the 351-400 band and sits in the 201-250 band for Arts and Humanities. In 2020, ACU also appeared in the CWTS Leiden Ranking for the first time and was the



leading Australian university in the Humanities and Social Sciences when ranked both by the proportion of papers in the top 5% most frequently cited (a scientific quality measure) and by the proportion of papers demonstrating interinstitutional collaborative publication.

ABOUT THE INSTITUTE OF HUMANITIES AND SOCIAL SCIENCES

Under Director Professor Joy Damousi, the recently-established Institute for Humanities and Social Sciences will support ACU's continued growth and success in the humanities and the social sciences. The Institute will consist of a number of research centres across the disciplines of History, Political Science, Sociology and Literature.

The Institute is currently recruiting Professors in Political Science to continuing, research-only positions. * see explanation note.

Applications are welcome from outstanding scholars across subfields in Political Science with special preference for those whose research interests include comparative political economy, historical political economy, political development, and political behavior. Candidates who use quantitative methods are especially encouraged to apply. The position is open as to regional specialisation, including America.

Applicants should hold a Ph.D. in political science, economics, or a closely related discipline. Successful candidates will have a demonstrated record of conducting outstanding research appropriate to the level of Professor in Political Science.

*Explanation note: These positions are not fixed-term but continuing, which, in the Australian context, means there is no end date and would normally continue until such time as the staff member resigns or retires.

POSITION PURPOSE

The successful applicants will be outstanding scholars of significant international standing in Political Science. They will publish high-quality research in leading international outlets that strengthens ACU's research reputation and positions the University as a sector leader in the discipline. The successful applicant may also undertake a leadership role within the Institute for Humanities and Social Sciences.

In addition, successful applicants will contribute to the research life of the Institute through leading collaborative grant applications, enhancing research partnerships, participating in research seminars, and attending conferences to disseminate the outcomes of their research. The successful applicants



will attract and supervise Higher Degree Research students, advise on the development of research-related teaching initiatives and contribute to the collegial culture of the University, consistent with the expectations of the duties of a Professor.
