POSITION OVERVIEW

The primary purpose of the Biosafety and Biosecurity Officer is to ensure the University community understands and is compliant with its obligations under a range of Federal, State and local legislation that govern research conducted in the areas of biosafety, biosecurity, quarantine and gene technology. The position is responsible for the Deakin University Institutional Biosafety Committee and assists the committee to carry out its biosafety training and monitoring obligations.

PRIMARY RESPONSIBILITIES

- Provide expert advice to the Pro Vice-Chancellor, Researcher Development and Integrity and Manager, Research
 Integrity on all matters pertaining to biosafety and biosecurity.
- Lead the coordination of biosafety and biosecurity across the University including providing executive management to the Institutional Biosafety Committee (IBC), appropriate committee membership and regular committee training.
- Develop and deliver the educational program for biosafety and biosecurity ensuring all relevant staff and students are aware of their legislative obligations when working with biological materials.
- Monitoring compliance with the relevant legislation, which includes coordinating facility inspections and providing guidance on new facilities.
- Ensure the University community understands and is compliant with its obligations under the Australian Code for the Responsible Conduct of Research in relation to biosafety and biosecurity and oversee the management of breaches and serious breaches.
- This role has staffing responsibilities and must therefore ensure staff and own adherence to University policies and procedures, including but not limited to those relating to equal opportunity, occupational health and safety, risk and financial management, privacy, staff development and staff performance planning and review.

KEY DUTIES

- Develop internal policies and procedures to ensure compliance with external Standards, Codes and Legislation relating to biosafety and biosecurity, including gene technology, quarantine materials, containment facilities and SSBAs.
- Develop, coordinate and conduct training for research academics, research support staff and students in their obligations, to ensure research is compliant with all relevant, standards, codes and legislation.
- Ensure implementation of biosafety and biosecurity legislation including ensuring the information provided to researchers through the website is clear and accurate.
- Provide feedback, in consultation with key stakeholders, to relevant regulatory bodies into relevant draft legislation, codes and standards to ensure University representation.
- Manage the Biosafety and Biosecurity team, providing leadership and guidance on all processes and procedures designed to ensure the efficient management of the area.
- Manage and support laboratory safety initiatives and staff, as directed by the Manager, Research Integrity.

- Actively engage and provide high-level advice on complex policies and procedures in relation to research integrity, biosafety and biosecurity, such as preparation of reports for the Research and Research Training Committee and other University units as required.
- Any other duties as directed, commensurate with the scope and classification of the position.
