## Building an inclusive, diverse and active humanitarian movement based on voluntary service

#### Role purpose

The Volunteer Mentor provides valuable mentoring support as a pro-social role model to adults pre and post release who have limited or no community support. They will provide support by assisting the client to undertake monthly Sponsored Leave from the jail as part of their progression to Parole. The Mentor will also support the person, gain important life skills and community connections as they transition back to living in the community. The Mentor may also continue support in the community once the client is released from gaol. Utilising a strengths based approach, the Mentor will assist the client to identify skills, competencies and interests and to build self-esteem through positive social connection.

#### **Role responsibilities**

- Provide mentoring support to adults on Sponsored Leave and post-release.
- Provide support towards achievement of any identified activities
- Providing support including attending planned appointments, supporting engagement with services and some transport
- Assist participants to identify their priorities and support with opportunities to link to the community in positive ways
- Regularly communicate and collaborate with Volunteer Mentoring Service Coordinator about clients being supported and provide information as required
- Maintain regular communication and engagement with clients at least twice a month prerelease
- Attend regular supervision and training as required
- Minimum time commitment of 12 months required

## Knowledge, skills and experience

- Well-developed communication and people skills
- Experience and/or interest and passion to work with people who are vulnerable and may have experienced complex trauma

- Attend scheduled volunteer meetings and supervision as required
