POSITION PURPOSE

A Level B academic is expected to make contributions to the teaching effort of the university and to carry out activities to maintain and develop her/his scholarly, research and/or professional activities relevant to the profession or discipline.

The Lecturer (Physiotherapy) will primarily be involved in the development and delivery of physiotherapy units across both the Doctor of Physical Therapy and Bachelor of Physiotherapy (Honours) courses including areas of public health, personal & professional development and university-based support for senior students undertaking clinical placements. Additional contributions to other aspects of our physiotherapy entry to practice programs may be required. Broad knowledge and experience across a range of clinical areas would be advantageous in order to expand student knowledge beyond foundational skills in areas such as musculoskeletal, cardiorespiratory and neurological practice, and develop competencies in more complex conditions applied to clinical settings.

KEY RESPONSIBILITIES

Specific duties required of a Level B academic may include:

- 1. The conduct of tutorials, practical classes, demonstrations, workshops, student field excursions, clinical sessions and/or studio sessions
- Initiation and development of curriculum material suited to entry to practice physiotherapy competencies
- 3. Acting as unit/subject coordinators; the preparation and delivery of lectures, seminars, tutorials etc.
- 4. Supervision of postgraduate students engaged in course work
- 5. Supervision of major honours or postgraduate research projects
- 6. The conduct of research
- 7. Involvement in professional activity
- 8. Development of course material with appropriate advice from and support of more senior staff
- 9. Marking and assessment
- 10. Consultation with students
- **11.** A range of administrative functions, the majority of which are connected with the subjects in which the academic teaches
- **12.** Attendance at departmental, school and/or faculty meetings and/or membership of a number of committees
- 13. Other duties as directed from time to time

KEY SELECTION CRITERIA

Education/Qualifications

- 1. The appointee will have:
 - A doctoral or masters qualification in physiotherapy or relevant discipline area or equivalent accreditation and standing

Knowledge and Skills

- 2. Possess a high level of interpersonal skills and demonstrated ability to work independently and as part of a team across both the education and industry sectors
- Demonstrated experience in curriculum and subject material development (including online materials)
- **4.** Demonstrated flexibility and capacity to contribute to an array of educational activities across a range of physiotherapy clinical and non-clinical subject areas
- 5. Demonstrated strong record of teaching experience in a tertiary environment
- 6. Demonstrated capacity to engage with industry partners within education models
- Demonstrated statistical and data analysis and manuscript preparation skills; including developing a solid track record of refereed research publications
- **8.** Ability to work positively and cooperatively with students, internal and external teams and external organisations

- 9. Demonstrated ability to motivate, actively engage and educate a given audience
- 10. Proven ability, commitment and passion for engaging in scholarly and research activities
- **11.** A demonstrated capacity to work in a collegiate manner with other staff in the workplace and external organisations
- 12. A record of demonstrable scholarly and professional achievement in the relevant discipline area
