Position Summary

The focus of this position is on high-impact weather events beyond temperature and rainfall alone, including compounding events and events that will have high impact in a future net-zero economy, such as the absence of wind or occurrence of fog. The position will involve identifying these high-impact events, describing their characteristics, as well as examining trends, variability, and the weather systems in which they occur. A range of modelling tools, including ultra-high resolution simulations developed within the Centre, will be used to assess the future of these high-impact events. There will be opportunities for working with industry partners in this process.

This position is fully funded by the Australian Research Council Centre of Excellence for the Weather of the 21st Century. The incumbent will contribute to and benefit from being a part of a supportive and vibrant Centre community which offers unparalleled networking and professional development opportunities.

The Centre is a major seven-year initiative funded by the Australian Research Council. It is a consortium of 24 partners led by Monash University in strong collaboration with The University of Melbourne, The University of New South Wales, The Australian National University, and the University of Tasmania.

The Centre's team-based research is focused on how Australia's weather is being reshaped by climate change. The Centre conducts blue-sky research with real-world applications for communities, industry and government. The research program is made up of six integrated Centre Projects: Weather System Dynamics; SSTs, Modes of Variability and Weather Systems; Weather Systems in a Warmer World; Weather Resources; High-Impact Weather; and Model Development and Applications.

This position forms an integral part of the Centre Project: High-Impact Weather.

The position is located within the School of Geography, Earth and Atmospheric Sciences at the University of Melbourne, supervised by Dr Andrew King in collaboration with colleagues at Monash University, the Australian National University, University of New South Wales, and University of Tasmania. Candidates seeking part-time or flexible work arrangements are encouraged to apply.

We encourage applicants from under-represented groups, including Aboriginal and Torres Strait Islander people. To allow us to consider performance relative to opportunity, we also invite applicants to provide a brief statement (up to 1 page) that describes circumstances that may have affected their career development or progression, including career interruptions or delays, periods of part time work, or forms of bias they have experienced.

1.1 RESEARCH AND RESEARCH TRAINING

The appointee will be expected to:

- Conduct novel research that advances understanding of high-impact weather in Australia.
 - Communicate research findings by publishing in highly ranked journals, presenting at relevant conferences and contributing to public-facing communications.
 - Interact with Centre of Excellence industry partners to increase usability of findings.
 - Assist with supervision and mentoring of undergraduate and graduate research students.
 - Assist in the preparation of proposals and submissions to external funding bodies.
 - Undertake tasks in relation to project management and project reporting as required.

 - ▶ Contribute to the preparation, or where appropriate individual preparation of research proposal submissions to internal or external funding bodies as relevant.

 - ▶ Contribute to and assist in the co-supervision and training of research students primarily at undergraduate level.

- ▶ Demonstrated ability to prepare research reports and manuscripts for publication.
- ▶ Strong evidence of ability and desire to build an academic research career trajectory.
- ▶ Demonstrated ability to engage with relevant professional and industry bodies and stakeholders to foster collaborative partnerships.
- ▶ Excellent interpersonal and both written and oral communication skills in English.
- ▶ Excellent ability to work co-operatively and positively in a multi-disciplinary research-based team environment and liaise with people from diverse backgrounds.
- ▶ Demonstrated excellent organisational skills to meet deadlines and bring projects to a timely completion.
- ▶ Demonstrated ability to develop, administer and see through to completion appropriately designed research projects with limited supervision.

2.2 DESIRABLE

- ▶ The ability to attract external funding through grant applications and/or support in funded joint projects with others internal or external to the university.
- ▶ Experience in assisting with supervision of students undertaking undergraduate or higher degree research projects.
