#### Role purpose

The Red Cross Baby Seats is a team of child restraint professionals dedicated to maintaining the safety of children in cars.

The Infant & Child Restraint Fitter Volunteer will assist with the efficient and safe fitting of infant restraints in client vehicles and contribute to maintaining the safety of children in cars.

#### **Role responsibilities**

- Provide prompt and efficient customer service
- Install and adjust child restraints according to manufacturer's instructions
- Demonstrate how to use child restraints with the customer and discuss any installation issues
- Remove restraints from customers vehicles
- Check restraint document to ensure all information is accurate
- Assist with hired product returns and documentation as required
- Ensure goods are cleaned appropriately and reassembled for reissue
- All goods to be checked for faults, damage and general wear and tear
- Ensure vehicles allow for safe installation of a restraint

#### Knowledge, skills and experience

- Ability to communicate effectively with a broad range of people
- Physically fit and able to lift and bend with the manual dexterity to pick up small objects such as screws
- Ability to work in a team environment
- Attention to detail and basic administrative skills for filling out fitting sheets
- Good problem-solving skills and hands-on attitude
- Previous experience with the installation of child restraints (desirable)

- Working with Children's Check DCSI Child Related (Red Cross will arrange this)

- Attend Red Cross Volunteer Induction, Program Training and ongoing training as required
- Attend scheduled volunteer meetings, a minimum of two per year
