## ***Position Summary***

### **1.1 ABOUT LABORATORY AND TECHNICAL SERVICES**

The laboratory and technical function delivers a range of services across research, teaching and other technical spaces. The function's key objective is the smooth facilitation and support of academic and research activities within the FEIT. The Laboratory and Technical Services team sits within this function, and involves five laboratory clusters:

- Mechatronics, electronics and digital,
- Fluid dynamics, energy & propulsion,
- Structural, geotechnical & environmental,
- Chemical, materials and manufacturing and
- Biomedical & Bioengineering.

The Laboratory Technician may be required to work across all clusters within the Laboratory and Technical Services team.

### **1.2 ROLE OVERVIEW**

The Laboratory Technician will support the cluster lead with the day-to-day operations of all laboratories within the cluster. They will be responsible for maintaining and operating laboratory equipment and assisting academic staff to ensure effective use of the laboratory equipment.

The Structures, Geotechnical and Environmental Cluster is comprised of a broad range of laboratories (structural testing, concrete batch plant, rock mechanics, geotechnical, ecology) that support research and teaching requirements across multiple topics and fields of research, including (civil and structural engineering, environmental hydrology, offshore geomechanics).

This role reports directly to the Cluster Lead.

## **2. Key Responsibilities**

- Be the go to resource in the field of speciality to deliver technical and expert services and support to teaching and research activities.
- Instruct, advise and support staff and students on the use of laboratory equipment and online management systems, including demonstrations, to ensure equipment is used effectively.
- Facilitate purchases of new plant and equipment, including ensuring operational, spatial and OHS requirements are met and maintained.
- Maintenance of laboratory equipment, including, but not limited to scheduled services, break fix, calibration and safety compliance.
- Support laboratory inventory and procurement of general laboratory consumables to support teaching and research activities.
- Maintain laboratory documentation to keep accurate records of teaching and research activities.
- Complete laboratory Quality and OHS requirements to meet compliance and safety obligations including but not limited to undertaking inspections and self-audits, and reviewing and/or developing risk assessments, SOPs, chemical manifests, local area inductions.
- Provide technical support and expertise to speciality areas (i.e. experience with analytical equipment and water and environmental data collection, analysis and instrumentation).
- Prepare and support practical classes and fieldtrips for teaching and research activities, including multi-day off-site activities.
- Manufacture rigs of equipment to support experiments.
- Support the facilitation and conduct of testing to comply with Australian Standards, American Society of Testing Materials (ASTM), ISO Standards, NATA.

## **3. Selection Criteria**

### **3.1 ESSENTIAL**

- A relevant degree and/or trade, or an equivalent combination of relevant experience and educational training supporting teaching and research facilities in higher education and/or industry R&D sector specific to environmental hydrology
- Strong interpersonal, written and verbal communication skills with the ability to work as part of a team, and independently.
- Demonstrated ability to prioritise, meet deadlines and work efficiently in a busy environment with large volumes of activity.
- A customer service mindset with experience maintaining high quality service to a range of customers.
- Initiative and motivation, with a capacity to contribute to short and long-term planning in the timely delivery of services.
- Familiarity of Australian occupational health and safety (OHS) legislation and laboratory regulatory and statutory requirements.
- Commitment and adherence to the highest standards of scientific and ethical integrity.
- Experience with measurement and analytical systems and equipment for water and environmental data collection and data acquisition systems and telemetry.

- Experience in conducting testing to comply with Australian Standards, American Society of Testing Materials (ASTM), ISO Standards, NATA Australian.
- Compliance to state and federal Government guidelines and regulations including but not limited to BICON, OGTR and Quarantine.

### 3.2 DESIRABLE

- Experience maintaining and operating relevant equipment.
- Experience working with a scientific laboratory environment.
- Experience working offsite on fieldwork.
- Experience in a tertiary education environment.
- Experience with using online laboratory management systems.
- High Risk Work Licences to perform high risk activities such as Forklift truck operations and Dogging.

Required to exercise own technical judgment and discretion to provide highly specialised technical services, set up complex experiments within laboratories and assist honours and postgraduate students with their laboratory requirements.

Role is required to perform tasks/assignments that require proficiency in the laboratory's existing policies, procedures, systems, processes and techniques and to adapt those procedures and techniques as required to achieve objectives.

Does not have budgetary or supervisory responsibilities.

### 4.5 BREADTH OF THE POSITION

Operates within a specialist technical sub-discipline providing services across Schools.
