Overview of program

Child and Family Services in the St Luke's Region consist of a range of programs that provide support to families who have dependent children 0-18 years.

The aim of Child and Family Services is to provide quality in-home and community interventions, with ranging intensities. Services and support is delivered in a child-centred, family focused way and works alongside families to address the changes that may need to occur for their children to be safe at home. These services include: Integrated Family Services, Changing Futures and placement prevention programs such as Stronger Families and Families First.

Families First is a placement prevention program that works with families across 6 Local Government Areas:

- City of Greater Bendigo
- Macedon Ranges
- Mt Alexander
- Central Goldfields
- Loddon
- Campaspe

The program provides 6-8 weeks of flexible intensive support and has three areas of focus - Placement Prevention, Long Term Placement Prevention and Re-unification.

Position Objectives

1.	To represent the agency with integrity and promote and uphold the agencies values.
2.	Provide quality interventions and services that focus on outcomes to families experiencing vulnerability and the safety and wellbeing of children.
3.	Undertake regular risk and needs assessments utilising the Best Interest Framework and other contemporary frameworks and theories.
4.	To prevent and/or reduce the rate of children entering the child protection system and/or out of home care.
5.	Promoting and engaging in relationships with Aboriginal Controlled Organisations and Aboriginal families that promote culture as a safety for children.
6.	Meet program and adhere to relevant policy, practice guidelines and legislative requirements.

Key responsibilities

The key responsibilities are as follows but are not limited to:

1.	To provide intake, assessment and case management response and support to children, young people and their families that focus on safety, stability and wellbeing.
2.	Actively engage children, young people and families, including those who may be resistant, by providing flexible and responsive service delivery. This will involve – assertive outreach visits, flexible service delivery hours and using a client centred, strengths-focused practice approach.
3.	Make an active commitment to the development and maintenance of a learning environment and cohesive multi-disciplinary team, through staff meetings, team meetings, staff development, supervision and reflective practice.
4.	Develop good working relationships with Aboriginal lead agencies to ensure cultural safety in our practice and good outcomes for aboriginal children and young people.
5.	Work within a collaborative care team approach with the school community, other relevant stakeholders, including Child Protection and Aboriginal organisations, to promote best outcomes for client.
6.	Fulfil the program obligation regarding case load requirements, targets, case recording, statistics and other data collection.
7.	Support an integrated service system for all families by working across child and family programs to support times of high demand.
8.	Other duties as requested by the Team Leader or Program Manager.

Key Selection Criteria

The Key Selection Criteria are based on role specific requirements **and** the Anglicare Victoria Capability Framework. Applicants are required to provide a written response to **both** a) and b).

a) Role specific requirements

Applicants are required to provide a written response to the role specific requirements. The five criteria are to be addressed individually (no more than 2 pages in total).

	<p>3. Demonstrated ability to conduct comprehensive safety and wellbeing assessments and work within the Best Interest Principles ' as outlined within the Children, Youth and Families Act 2005</p>
	<p>4. Sound understanding of the Child Protection and welfare system, and experience in collaboration with a range of professionals in a care team approach.</p>
	<p>5. Excellent written and verbal communication, time management and organisational skills.</p>

Key Selection Criteria (continued)

b) Anglicare Victoria Capability Framework

Applicants are required to provide a written response to the Anglicare Victoria Capability Framework. Applicants are to describe how they demonstrate the characteristics in each of the two capability groups; **Personal Qualities and Relationship and Outcomes** (no more than 1 page in total).
