Work with regions/sites to implement the Health & Safety Management System and any risk reduction programs. Work with regions/sites to develop and deliver local improvement plans. Key Result Area 2 – Coaching & Communication	

Key tasks

- Identify and develop strong relationships with local leaders, influencers and stakeholders.
- Coach leaders in risk management principles and key Mission Australia health & safety processes such as incident investigation and risk assessment.
- Partner with and coach leaders in how to engage their teams in such a way that it positively impacts on the creation of a culture that supports health & safety.
- Work with sites to ensure the quality of investigations, risk assessments and other activities meet Mission Australia standards.
- Ensure regions are kept up-to-date with changes to legislation and learnings from incidents (internal and external).

Position holder is successful when

- Feedback from leaders, influencers and stakeholders indicates relationship is strong.
- Leaders are growing in their knowledge and understanding of their roles and Mission Australia's risk management processes.
- Leaders take ownership in creating a culture that supports health & safety
- Issues are identified and recommendations made to the Health & Safety Manager.
- Communication with regions is regular and information provided is relevant to their operations.

Key Result Area 3 – Review & Report

Key tasks

- Review and update Health & Safety
 Management System documentation in accordance with legislation and business needs.
- Conduct risk reviews and audits
 of site activities against plans and Mission
 Australia's health & safety standards.
- Review online incident reporting and work with sites to ensure report quality meets required standard.
- Provide reports as required to meet business needs.
- Conduct health & safety due diligence reviews of new or potential projects as required by the business.

Position holder is successful when

- Feedback and follow up on incident reports, investigations and subsequent action is completed.
- Health & safety information and data is provided when required for monthly and quarterly reports for executive teams and other ad-hoc reports as required.
- Inspections and audits are completed as per the schedule with reports provided to the relevant managers.
- Subject matter expertise is provided on planned tenders, building fit outs and new leases.

Work Health and Safety
