

## ROLE DESCRIPTION - Science (Years 7-12) Ability and willingness to teach at least one other subject is required. Permanent 1.0 - 2025

- Science Classroom Teacher
- Ability and willingness to teach at least one other subject is required.
- Contribution to the co-curricular life of the College including coaching sporting teams before/after school, involvement in College camps and retreats and support of the co-curricular program at the College.
- Meet the requirements for full registration/accreditation through the Australian Professional Standards for Teachers demonstrating achievement of all the Standard Descriptors at the relevant level.
- Developing positive and professional relationships with staff and students.
- Teaching of allocated Classes following NESA Curriculum Outlines.
- Assist in the organisation and management of teaching programs and associated resources.
- Maintain accurate class attendance rolls.
- Participant in faculty staff meetings and whole staff meetings.
- Attend Staff Briefing (Tuesday 8.30am).
- Dress according to professional standards as set by the College Principal.
- Follow scope and sequences in each course and teach the differentiated curriculum to meet the educational needs of all students.
- Manage, mark and record students' assessment tasks inclusive of both outcomes achieved and levels of achievement.
- Write student semester reports and be available for all Parent/Teacher Interviews.
- Assist with rostered and active duty supervision of students.
- Compliance with all professional codes of behaviour and legal responsibilities including the CEDB Code of Conduct, Duty of Care, Child Protection, Privacy and WH & S requirements.
- Support College events and activities including attendance at whole school assemblies/liturgies.
- Participate in the College's professional Professional Practice and Development Program including goal-setting and annual review.
- Support year group and/or house team affiliations.
- Other roles as directed at the discretion of the College Principal.

**Selection Criteria:** It is anticipated that applicants for this role will be able to demonstrate:

- the desire to engage with and contribute to a Catholic learning organisation
- effectiveness as a classroom teacher who meets the requirements for full registration/accreditation through the Australian Professional Standards for Teachers demonstrating achievement of all the standard descriptors at the relevant level.
- qualifications and/or experience in teaching across other KLA areas.
- a proven ability to teach with an advanced understanding of contemporary teaching and learning practices
- a proven capacity to facilitate the integration of ICT in contemporary learning practices
- a capacity to collaborate within a diverse team
- Strong communication, organisation and administrative skills.
