Reporting to the Tax Manager, my role is primarily to ensure the fulfillment of the Virgin Australia Group's Corporate Income Tax and International Tax reporting and compliance obligations for Australia, New Zealand and other relevant jurisdictions. Further, my role requires me to provide high-quality taxation advice on operational issues and major transactions undertaken by the Virgin Australia Group as required.

My role involves continued refinement of processes and documentation around them, to help improve the overall operations of the Virgin Australia Group tax function while taking into account, and managing, the requirements of the corporate and operational areas of the Virgin Australia Group.

## **Key Accountabilities**

#### Advisory & Research:

- Advice on the corporate and international tax implications of the Group's corporate transactions and operations, including income tax, capital gains tax, transfer pricing and withholding tax.
- Engagement with revenue authorities in relation to risk management, ruling requests, compliance, etc. regarding corporate and international tax issues.
- Reviewing domestic and international contracts to ensure tax risks of Virgin Australia are adequately determined and managed.
- Identify saving strategies where relevant.
- Identify, develop and deliver necessary training across the business relating to corporate and international tax risk

#### Risk identification & process and systems enhancement:

- Identify, manage and review the following risk areas:
  - o Income Tax
  - o Transfer Pricing & other International Taxes (i.e. BEPS etc.)
  - o Thin Capitalisation
  - Withholding Tax
  - Tax Losses
  - Other foreign tax requirements
- Documentation of all corporate tax and international tax risks, communication with the broader business of those risks, and identification of mitigation strategies within the Virgin Australia Group's tax risk appetite.
- Evaluation and implementation of process improvement opportunities, including innovative technology solutions, such as robotic process automation, where appropriate.

#### Compliance:

- Complete the following compliance obligations (returns, filings, instalments, remittances) with assistance from external advisors where appropriate:

  - Virgin Australia Group Income Tax Returns in Hong Kong
  - Virgin Australia Group Tax Effect Accounting and Statutory Reporting
  - o Country-by-Country Reporting obligations
  - Withholding Tax Returns in Australia and foreign jurisdictions
  - o Other income tax and international tax obligations in foreign jurisdictions
- Assist in the ongoing management of ATO, NZIRD and foreign jurisdiction tax authority relationships and reviews.
