Supervision of Honours, Masters and HRD students and research projects.

Undertake teaching-related administrative duties as required.

Maintain current knowledge of standards of practice and required student assessment procedures and ensure these are completed to the required standard and timeframe.

#### Contributes to research outcomes within discipline or area of expertise

Conduct excellent scholarly research and publication that is consistent with the broad research aims of the Law School, independently and/or in collaboration with others, both within and external to the School and University.

Foster the research of other groups and individuals in the Law School.

Produce high-impact scholarship and disseminate it through publication in highly-ranked peer-reviewed journals.

Actively seek, independently and/or in collaboration with others, research funding from external sources.

#### Service and Engagement

Contribute to the governance and collegial life within the Law School, University and more broadly outside the institution.
