The position plays a key role within the Finance department and is responsible for oversight and efficient management of cash, banking and treasury functions as well as ensuring BSL's timely compliance with all federal and state taxation related matters. In addition, this position is responsible for the implementation of BSL's investment strategy and policy and development of processes to monitor cashflow and investment performance.

The position works proactively and in close collaboration with wider Finance team and other stakeholders, with an aim to improve the existing financial processes and provide solutions for changing business requirements. The core deliverables for this role are efficient delivery of treasury, tax and investment functions as well as setting, analysing and presenting key financial data to assist Senior Management in making critical business decisions. This role manages 1-2 persons and is responsible for managing, driving and assistance with various projects across the Finance team and in collaboration with other teams.

#### **KEY RESPONSIBILITIES**

# Leadership

- Oversight and management of a small team
- Supporting, coaching and development of team members, sharing knowledge and resources across Finance team

#### Tax

- Management of all tax matters, including BAS, FBT & Franking returns etc. in collaboration with the financial accounting team
- Maintain Tax Governance Framework
- Oversight, advice, liaison with and education to business units, management and finance to ensure tax compliance is achieved effectively and with optimised cost structure, partnering with tax advisory when required
- Collaboration with third parties, including but not limited to the ATO and BSL salary packaging service provider.

# Treasury & Cash

- Development and maintenance of Treasury policy, cash flow reporting and forecast processes, including input to long term and short-term organisational planning.
- Daily operational cash management, long term strategic planning.
- Loan management if and as required, including compliance and reporting
- Development of action plans for management and committee to consider, implementation of agreed actions.
- Oversight of all banking, banking signatories and corporate card administration.
- Managing inflows and outflows of the BSL funding model, including reporting monies received and/ or distributed from fundraising, government grants and bequests.
- Work closely with fundraising team to ensure that bequests, donations and gifts are managed within the correct accounting standards and tax considerations.

#### Investments

- Implementation of Investment Policy & Strategy and related accounting, in close collaboration with external investment fund managers, the Finance team and Finance & Investment Committee (FIC).
- Management of compliance requirements of variety of funds, such as residential bonds.
- Compile accurate, complete and timely monthly finance reports, forecasts and analysis for presentation to the Executive and Board, including all journals and reconciliations as required.

# **General Topics**

- Identify and document organisational risks and opportunities
- Transparent and informative reporting, accounting procedures in the area of responsibility
- Create and maintain relevant processes and procedures
- Ensure compliance with and enhancement of internal controls and control over funds
- Assistance with provision of information for the internal and external audit programs as required
