Position Purpose

This position will lead a team providing specialist technical engineering expertise and undertake complex investigations for a range of stormwater infrastructure, drainage, and flood related matters under a number of Capital and Operational programs to meet the needs of the community within the City of Moreton Bay area.

Responsibilities & Outcomes

As a Team Leader Stormwater Infrastructure and member of the Drainage, Waterways and Coastal Planning department you will:

- Lead the delivery of cross divisional stormwater infrastructure projects under a range of Capital and Operational works programs that address legacy issues, support regional population growth and drive integrated and sustainable outcomes.
- Lead a team of technical specialists providing strategic and expert advice to key stakeholders in line with contemporary best practice and council's policy and strategic business requirements.
- Investigate complex stormwater infrastructure, drainage, and localised flooding problems and prepare and present technical reports and recommendations to ensure project outcomes are met.
- Manage the timely review and provision of expert advice to other Infrastructure Planning departments on stormwater elements of design projects.
- Coordinate and/or undertake design studies into stormwater infrastructure improvement opportunities to support infrastructure projects and long-term strategic planning and growth (including management of specialist consultants).
- Oversee the planning and delivery of stormwater infrastructure projects, including completing the concept/functional and detailed design, preparation of costings and the acquisition of necessary approvals to ensure project outcomes are achieved.
- Develop team capability to drive a high performance, continuous improvement and customer focussed culture.
- Build strong relationships with internal and external stakeholders to ensure stormwater & waterway infrastructure and service delivery outcomes are achieved.
