


RURAL PSYCHIATRY TRAINING WA (RPTWA)

About WACHS

The WA Country Health Service (WACHS) is the largest country health system in Australia and one of the biggest in the world, providing health services to approximately half a million people, including 45,000 Aboriginal people, over a vast two and a half million square kilometre area. The organisation comprises seven regions, with a strong network of public hospitals, health services and health centres located across rural and remote Western Australia. Our core business is the provision of quality, accessible health services to country WA residents and visitors.

Providing high quality and culturally secure care and treatment for people experiencing mental health problems, including alcohol and substance use disorders, in rural and remote Western Australia is core business for WACHS. We recognise and value the importance of good mental health for all country people, and how it impacts on quality of life and the ability for people to be contributing members of the community.



Overview of the RPTWA Program

Rural Psychiatry Training WA (RPTWA) is Australia's first ever dedicated rural Psychiatry training program. Run by an experienced team from our Bunbury training hub in WA's picturesque South West region, RPTWA provides comprehensive rural training at over 30 RANZCP accredited posts.

Comprehensive Training Hubs

Stage 1 trainees are allocated to one of four Comprehensive Training Hubs, which each have the full range of training posts required for completion of a 5-year generalist RANZCP Fellowship.

- **Great Southern** Albany
- **Kimberley** Broome
- South West Bunbury
- Midwest Geraldton

Rural Training Centres

Stage 2 & 3 Trainees also have the option to explore the unique and well-supported training posts available at each of our Rural Training Centres.

- South West Busselton
- Pilbara Port Hedland
- Wheatbelt Northam

APPLICATION TO JOIN THE RPTWA PROGRAM

Eligibility to work as a Registrar in WA

To be considered for a Registrar position, you must be:

- eligible for registration with the Australian Health Practitioner Regulation Agency (AHPRA)
- an Australian citizen or permanent resident or have a visa to work in Australia.

Preparing your application

Selection Criteria

Selection criteria cover the skills, qualifications and experience considered necessary to successfully perform the duties of a Rural Psychiatry registrar.

You are not required to prepare a separate statement addressing how you meet each of the selection criteria, as these criteria will be assessed as part of the selection process.

For successful entry into the RPTWA program you must be able to demonstrate the following:

Essential Criteria

- 1. Commitment to a rural post in psychiatry.
- 2. Good interpersonal skills and high-level communication skills.
- 3. Two-year equivalent full time Medical Officer experience (PGY 2).
- 4. Eligibility for full registration with AHPRA (Australian Health Practitioner Regulation Agency).
- 5. The ability to satisfy the Selection Panel of suitable academic record and employment history.

Desirable Criteria

- 1. Clinical competence in both General Medicine and Psychological Medicine.
- 2. Ability to use proficient problem-solving techniques, coping strategies and ability to tolerate and deal effectively with stressful situations.
- 3. "C" Class Driver's Licence.
- 4. Rural background and/or rural clinical experience
- 5. Experience working with Aboriginal and Torres Strait Islander peoples.

Curriculum Vitae

All applicants must attach their curriculum vitae (CV) on the template provided.

Your Curriculum Vitae MUST include:

- Details of your educational background.
- Medical employment history including any involvement with research.
- Any experience working in mental health in rural communities and/or working with Aboriginal and Torres Strait Islander peoples.
- Any experience working in professional non-medical roles in a rural setting.
- Names and contact details of three referees.
- Top 3 location preferences.

Personal Statement - Why Rural Psychiatry?

Applicants are requested to write a personal statement explaining why you wish to train as a rural Psychiatrist, which aspects of psychiatry you are most interested in and your career plans within psychiatry. The statement should not exceed 300 words and does NOT need to be handwritten.

RPTWA – Application Form

Applicants are required to complete the RPTWA Application form.

Cover Letter

You may attach a cover letter (maximum of one page) if you wish.

Application

The 2025 intake application includes questions on:

Citizenship and Residency

• Australian citizenship or permanent residency is preferred and will be considered accordingly.

Qualification and Registration

- Registration with AHPRA your current registration status, AHPRA number and registration pathway.
- English language competency if applicable outcome of any assessments of English competency to meet the requirements of the Medical Board of Australia English language skills registration standard.
- Medical qualifications details of your primary medical degree medical school, country of qualification and year of completion.
- Only certified* and translated copies (where applicable) will be accepted.

Employment and Training

- Medical employment history details of all employment as a registered medical practitioner. Any breaks in employment must be explained.
- Statements of Work Performance a statement from each hospital/training scheme or practice at
 which you have been employed for at least the last 24 months. For PGY1 and PGY2s, a letter from your
 Director of Prevocational Training can be submitted commenting on work performance and the terms

completed, or you can submit copies of end of term reports. For PGY2s and above please arrange a letter from the Clinical Director or similar.

Referees

You are required to nominate three professional referees from past and present immediate clinical Supervisors and/or relevant Directors of Medical Services who can give an accurate picture of your capabilities. At least one should have provided supervision in a clinical placement.

More value will be placed on referees who are psychiatrists and those who have been clinical supervisors. Please ensure that you provide a valid email address and a current telephone number.

Your referees may be contacted by the health service at any time throughout the submission period and asked to complete a report. This confidential ¹ report is used for the explicit purpose of assisting with the selection process and is only made available to the Selection Panel. Any inconsistent or non-supportive comments made by referees will be followed up with a personal phone call from a member of the Selection Panel.

If a Referee has any technical difficulties with submitting their report, they should contact the RPTWA team for assistance.

Please follow up with your Referees to ensure that Referee Reports are submitted on time.

Ensure you have a valid email address and at least one current telephone number for each referee. It is recommended that you contact your referees before you submit your application to confirm that they consent to providing a confidential referee report and that their contact details are correct. Once applications close you are no longer able to add a new referee. If you need to add an additional referee after this date, please contact rptwa@health.wa.gov.au.

If you need to update your current referee email addresses, you can update this in your own profile on MedCareersWA.

You do not need to attach written references or completed referee reports to your application. To add referees during the application process, click 'add new referee' and complete the fields:

Enter the details for your first referee and click the save button. Repeat this process for your second referee.

Declarations

You will be required to make declarations regarding the requirements and responsibilities of working as a Registrar and being eligible for registration with AHPRA.

¹ Please note the limitations to this confidentiality. Applicants must be given the opportunity to respond to any adverse comment prior to interview. Applicants will not be told who made the adverse comment. Additionally, applicants may be able to apply to the courts for access to references.

Attachments

The following types of documents must be attached to your application:

- 1. CV (must be completed on the template provided).
- 2. "Why Rural Psychiatry" statement and optional Cover Letter
- 3. RANZCP Program Application Form & Declarations
- 4. Proof of Citizenship/Residency status e.g., copy of passport <u>and</u> (if applicable) copy of current visa OR Australian birth or citizenship certificate.
- 5. Evidence of English language skills registration standard (if applicable).
- 6. AMC Certificate and exam result (if applicable).
- 7. A copy of your AHPRA Certificate of Registration (available on AHPRA website), or equivalent.
- 8. Statements of Work Performance

It is recommended that you have these documents ready before you start your online application.

Copies of documents must be in English, and certified (e.g. signed by a State Public Servant, Justice of the Peace, etc).

The accepted formats of documents are .doc, .docx, .pdf, .jpeg, .gif and .xls.

Please note .pages and .png are not accepted formats.

Principles Underpinning Selection

Applicants are selected for the RPTWA program based on their suitability, skills, and experience to ensure:

- that they are capable of providing psychiatric care to the standard expected by people with mental health problems and mental illness in Australia
- they are potentially capable of completing the training program within the time allowed.

All trainees must have the requisite skills, competency, and qualifications in general medicine prior to entry to enable the development of core psychiatry skills in the integration of physical and mental health.

Equal Employment Opportunity/Accountability & Governance

The selection process acknowledges and abides by the guidelines of Equal Employment Opportunities as governed by the Public Sector Standards Commission, ensuring all applicants are treated in a fair and impartial manner.

For the RPTWA training zone, the selection process is managed by the Subcommittee for Rural Psychiatry Training WA, a subcommittee of the WA Branch Training Committee. Following the selection process the Selection Panel forwards its recommendations to the WA Branch Training Committee for ratification.

Number of training positions available

This intake is for Stage 1 training entry at two of the RPTWA Comprehensive Training Hubs:

- 1 position for RANZCP Stage 1 entry in Albany, Great Southern Region
- 1 position for RANZCP Stage 1 entry in Geraldton, Midwest Region
- 2 positions for RANZCP Stage 1 entry in Bunbury, South West Region

There is also the potential of 1 position for RANZCP Stage 1 entry in Broome, Kimberley Region. Applicants are requested to include this in your preferences if interested, however this position will not be confirmed until later in 2024.

Selection

All applications will be screened by the Selection Panel to determine eligibility and shortlisting for the selection interview.

Ineligibility can arise from:

- Past exclusion from, or unsatisfactory performance in, a Psychiatry Training Program (at the discretion of the WA Branch Training Committee).
- Not having the ability to achieve general medical registration by February 2025.
- Not having Australian citizenship or permanent residency at the application closing date.
- Failure to demonstrate achievement of essential criteria.

Applicants are selected based on their written application, curriculum vitae, referee reports and performance at interview.

Depending on the number of applicants, there may also be a shortlisting process, with only selected applicants proceeding to the interview stage. An objective and transparent process of shortlisting will be used, based on the assessment criteria below. Applicants will be given timely notice of whether they have been shortlisted.

The Selection Panel

The selection and interview panels for Stage 1 entry to the RPTWA program are made up of:

- Chair of the WA BTC Subcommittee for Rural Psychiatry Training WA (FRANZCP) or delegate.
- RPTWA Director of Training (FRANZCP)
- Psychiatrists (FRANZCP) experienced in supervising trainees.
- A community representative from the WACHS Aboriginal Mental Health team.
- An RPTWA trainee representative.

These panels aim to have a mix of genders. Panel members will identify any applicants who might represent a conflict of interest for them, and this conflict is managed in compliance with WACHS requirements and RANZCP guidelines.

Assessment criteria of the Selection Panel

The Selection Panel will utilise both the Essential and Desirable criteria included in the intake job advertisement, as well as the following RANZCP criteria in the assessment of the required selection components for training:

- Academic performance.
- Employment history.
- Competence in general medicine.
- Experience working as a doctor in a psychiatric setting.
- Ability to work in teams.
- Understanding of psychological factors in medicine and psychiatry.
- Interpersonal and communication skills.
- Other useful experiences and skills.
- Professional conduct

The following desirable criteria are rated by assessment of the applicant's curriculum vitae, referee reports and interview:

- Above average performance in academic record.
- Above average performance in employment history.
- Above average level of competence in general medicine.
- Sound level of understanding of psychological factors in medicine and psychiatry.
- Demonstration of good interpersonal and communication skills.
- Proven ability to work in teams.

In addition to the above criteria, favourable consideration will be given to those applicants who can document the following experiences:

- Working with disadvantaged groups.
- Working with people from other cultures and Indigenous people.
- Working in rural areas.

• Having skills in other languages

The Selection Panel will assess a trainee's work performance from any hospitals and/or training schemes or practices in which an applicant has been employed during the 24 months leading up to the time of application, if applicable. This review may also extend to any earlier relevant employment.

Selection Process

The selection process follows three stages which are consistent with RANZCP standards and WA Branch Training Committee processes. Our process has been adapted in recognition of RPTWA's focus on Rural training and our commitment to supporting the next generation of Aboriginal psychiatrists.

Stage 1: Review of Written Application

Personal Statement

The selection panel will review the statement from an applicant explaining their rationale wishing to train as a rural psychiatrist, the aspects of psychiatry in which the applicant is most interested and/or any plans for the applicant's future career in psychiatry.

Curriculum Vitae

The curriculum vitae will be assessed against the selection criteria and should include all medical experience and details of all past psychiatric posts.

Scoring

All written applications are then scored against the assessment criteria, up to a maximum score of 40 points.

Stage 2: Review of Referee Reports

Referee Reports

Applicants are asked to nominate 3 referees who can provide information about the applicant's professional capabilities. A confidential pro forma referee report is sent to each referee. The Selection Panel will follow up references by telephone if necessary and appropriate.

In addition to the nominated referees, the Selection Panel may contact the Clinical Directors of units in which they have recently worked or their previous Director of Training. Applicants are given the opportunity to identify any previous Director with whom there has been conflict or to explain why a Director's comments may not represent a fair and unbiased assessment of the applicant's work performance.

References may contain confidential information, within limitations, and the applicant may not be aware of their content. An applicant with an adverse comment in their application documentation will be given the opportunity to respond to the comment before the formal interview. The College & RPTWA will not give an applicant the identity of a person who made an adverse comment; however, the applicant may be able to apply for access to references under the relevant Freedom of Information Laws.

Scoring

Each Referee Report is assessed against the following criteria, up to 20 points as follows:

There are also 12 referee questions which are each scored out of 5. They include information on the following:

- The applicant's competency in general medicine.
- The applicant's ability to work within a multidisciplinary team.
- The applicant's verbal and written communication skills and management of documentation tasks.
- The applicant's suitability for a career in psychiatry and grasp of psychological factors in medicine.
- The applicant's professionalism (for example: reliability, responsibility, organisation, initiative and ethical attitudes).
- The applicant's academic ability and attitudes towards developing their knowledge and skills.
- Applicant's collegiality with their peers, consultants and others in the workplace.
- Applicant's suitability to commence training in psychiatry in a rural setting.
- Any other relevant comments.

The scores for the referee assessment (out of 20) and referee questions (out of 60) are combined for each of the three referee reports. This overall total is then averaged and divided by two to give a final referee report score out of 40.

Stage 3: Shortlisting & Interviews

If there are more applicants than the available opportunities for interview, applications will be ranked by combining their written application score (out of 40) and their referee report score (out of 40).

Those who are successful in the shortlisting process will be invited to attend an interview. The interview will be objective and free from bias. The goal of the interview is to provide an opportunity for the applicant to demonstrate their suitability for rural training. To support the growth of our Indigenous Psychiatrist workforce, any applicants identifying as Aboriginal, Māori or Pacifica will be automatically shortlisted for interview.

- The interview will be held via video link as the panel members are working across rural WA.
- Members of the Selection Panel involved in the interview will to be introduced and their position/affiliation made known.
- The questions will be set prior to the round of interviews and the same set of lead-in questions will be asked of all applicants.
- Candidates will be given an opportunity to ask questions.

Final Ranking & Outcome

Suitability for rural psychiatry training is based on the standard of the application, the referee reports, and performance at interview. Candidates are ranked on standardised criteria including their written application score, referee report score and the average score received from the interview panel.

Candidates will be notified of the outcome of their application by email.

Feedback

After you have been advised of the outcome of your application you are invited to seek feedback. If you are not offered an interview, telephone feedback regarding your application is available, by appointment.

If you are unsuccessful at interview, face-to-face feedback via video link can be arranged, by appointment only. Appointments for feedback can be made by contacting RPTWA.

Appeals

The Western Australian Public Sector Management Standards provide that unsuccessful applicants have the right to appeal against the selection process if they believe a standard has been breached.

The relevant Public Sector Standards are as follows:

- The applicant's skills, knowledge, and abilities relevant to the training program are fairly assessed.
- The call for applicants is advertised as widely as practical.
- Bias-free documentation outlines the relevant selection criteria.
- Methodologies and their application are free from bias, patronage, and nepotism.
- Decisions and processes embody the principles of natural justice.
- Decisions are documented and capable of review.
- Confidentiality is maintained.

General information about your rights and the appeal process are available on the <u>WA Health</u> website. If an applicant is unsuccessful, they will be provided with more specific instructions for lodging an appeal at the time they are notified.

You may also request to appeal the decision via the formal RANZCP Appeals Process, which is available on the RANZCP website; https://www.ranzcp.org/about-us/governance/governance-documents.

HOW TO APPLY

MedCareersWA Application Process

WA Health advertises registrar positions on <u>MedCareersWA</u>. Applying for a position via <u>MedCareersWA</u> is simple:

- Create your personal profile including:
 - o medical registration details,
 - o education and employment experience,
 - o career and training pathways.
- Complete an application for your preferred position/s.
- Edit and save your application prior to the submission closing date.
- Submit your application prior to the submission closing date.
- Maintain and update personal contact details.

Note: Don't forget to submit your application! Saved applications are not automatically submitted at the closing of the application period. Applicants who do not submit their application prior to the closing date will not be considered.

If you do not follow the instructions on how to apply you will not be eligible for assessment and selection.

How do I apply online?

To view information and an informative explanation on how to apply, please visit the How to Apply section on MedCareersWA.

Sign Up

First time users will need to create a MedCareersWA account by selecting 'My Profile' at the right of the screen and complete the registration details. You will then receive an email to activate your account. Please use your formal name as it appears on your AHPRA registration.

Personal Details


In completing your personal details for your application please ensure that you use all your legal names (first, middle and family) as they appear on your medical registration, passport, birth certificate or driver's licence.

If you have a preferred name, please indicate this in the Preferred Given Name question.

Telephone numbers should include country and area codes as applicable.

How to add referees during the application process

You will need to add three referees to your application. To add the third referee, you will need to click on the add more button.



Submitting your application

All applications must be submitted by the close of the application period.

Late applications will not be accepted.

Saved applications are not automatically submitted. You can confirm your application status in the My Application History section of MedJobsWA. Submitted applications display as 'Complete'.

Please allow time to complete your application so that it can be submitted before the closing date and time.

Once your application is successfully lodged, you will receive an email advising that your application is complete.

You can edit your lodged application up until applications close. After this you will not be able to change your application. You can however update your contact details.

Assistance

Please include the name used for registration on your application (rather than preferred name) and your application ID.

Helpful Hints

- Scan and save your necessary attachments as soon as possible and ensure your files are within file size limitations.
- Attachments must be made using the pro formas when provided.
- Start your application early to allow time to deal with any issues that may arise.
- Have scanned certified copies of your passport/visa and electronic copies of other documents ready to upload.
- When entering your AHPRA number don't forget to enter the leading zeros.
 - Please enter your 9 digit AHPRA Registration Number



- Submit your application well in advance of the closing date and time if possible.
- An active, reliable email account is essential as ALL correspondence will be via email.
- For any problems experienced accessing <u>MedCareersWA</u> please send an email to: MedCareersWA@health.wa.gov.au
- It is recommended that you print a copy of your application for your own records.

Withdrawing your application

You can withdraw your application at any time.

- Visit MedCareersWA.
- Sign in using your preferred method, if you click login with one-time code, this will send a code to your registered email which you can enter to login to your account.
- Click 'Submitted applications' to view the position.
- To withdraw, click "Withdraw" from the drop-down list.

We understand that you might apply for more than one position. We ask that you inform us as soon as you have accepted another offer and no longer seek a position in rural WA. This allows us to consider other applicants.

If you withdraw, you will receive an email notification. You will also receive a quick survey to gather information to help us improve the way we manage our prevocational medical workforce.
