The Research Fellow will be charged with supporting the collaborative research program between UNSW Medicine and St John of God Healthcare in Trauma and Mental Health. The collaboration will develop a world leading research program Social Psychiatry concerned with the social and psychological determinants of mental health problems and their connections to trauma and adversity.

The role of Research Fellow reports to the Professor and has no direct reports.
