ROLE CONTEXT

Primary Objective(s) of role:

The Occupational Therapist (AHP2) is accountable to the Nurse Unit Manager for the provision assessment and treatment services for clients of Northern Mental Health, which aims to optimise health outcomes. The incumbent may rotate through a series of clinical services.

The Occupational Therapist applies clinical experience, clinical knowledge and professional competence to plan, implement and evaluate comprehensive and integrated services to the needs of clients of the Northern Adelaide Local Health Network.

The Occupational Therapist (AHP2) works under direct clinical supervision and may provide direction and support to Allied Health assistants and students.

The Occupational Therapist works collaboratively with the multi-disciplinary team and liaises directly with medical, nursing staff of NALHN and with other community agencies.

The NALHN Adult Acute Inpatient Services provides safe, high-quality patient centred care by ensuring the approach to service provision is trauma informed, recovery oriented and delivered within a therapeutic interdisciplinary framework.

The inpatient services seek to provide inter-disciplinary specialised acute assessment, risk management, care and treatment within an inpatient mental health setting and/or acute phase of illness. These mental health services aim to provide appropriated mental health services that help sustain illness recovery and community tenure.

An interdisciplinary approach is taken that involves team members from different disciplines working collaboratively, with a common purpose, to set goals, make decisions and share resources and responsibilities. The multidisciplinary teams, together with the client, undertake assessment, diagnosis, intervention, goal-setting and the creation of a care plan. The client, their family/significant others and carers,

where possible and appropriate, are involved in any discussions about their condition, prognosis and care plan.

Direct Reports:

- > The incumbent is responsible to the Nurse Unit Manager to whom they directly report.
- > The incumbent is professionally responsible to the discipline senior Occupational Therapist
- > The Occupational Therapist works collaboratively with multi-disciplinary team and liaises with providers of NALHN and other community agencies

Internal

- > Maintains close collaborative working relationships with the multi-disciplinary team.
- > Build and maintain relationships with other mental health teams and services, including NALHN Community MH integrated teams and primary health care to ensure an integrated service delivery.
- > Accepts direction from the Nurse Unit manager and Head of Unit for clinical workflow.
- > Accepts direction from the Lead Clinician in care planning when diagnostic ambiguity and conflicting clinical opinion are affecting ongoing consumer care

External

- > Liaison and collaboration with NGO psycho-social support providers and NDIS providers
- > Liaison with other government departments / service providers Liaison with Primary Health Care Services and GP's
- > Liaison with SACAT, Office of Public Advocate, and Public Trustees Office.

Special Conditions:

- > It is mandatory that no person, whether or not already working in SA Health, may be appointed to a position in SA Health unless they have provided a satisfactory current Criminal and Relevant History Screening, as required by the *SA Health Criminal and Relevant History Screening Policy Directive*.
- > For appointment in a Prescribed Position under the *Child Safety (Prohibited Persons) Act (2016)*, a current Working with Children Check (WWCC) is required from the Department for Human Services Screening Unit. For other positions, a satisfactory National Police Certificate (NPC) assessment is required.
- > For 'Prescribed Positions' under the *Child Safety (Prohibited Persons) Act (2016)*, the individual's WWCCs must be renewed every 5 years from the date of issue; and for 'Approved Aged Care Provider Positions' every 3 years from date of issue as required by the *Accountability Principles 2014* issued pursuant to the *Aged Care Act 1997 (Cth)*.
- > Appointment is subject to immunisation risk category requirements. There may be ongoing immunisation requirements that must be met.
- > Depending on work requirements the incumbent may be transferred to other locations across SA Health to perform work appropriate to classification, skills and capabilities either on a permanent or temporary basis subject to relevant provisions of the *Public Sector Act 2009* for Public Sector employees or the *SA Health (Health Care Act) Human Resources Manual* for Health Care Act employees.
- > The incumbent may be required to participate in Counter Disaster activities including attendance, as required, at training programs and exercises to develop the necessary skills required to participate in responses in the event of a disaster and/or major incident.
- > Must have a current SA driver's licence and willingness to drive a Government vehicle is essential.

General Requirements:

Northern Adelaide Local Health Network

The Northern Adelaide Local Health Network (NALHN) provides care to more than 400,000 people living in the northern metropolitan area of Adelaide as well as providing a number of state-wide services, and services to those in regional areas. NALHN works to ensure quality and timely delivery of health care, whilst building a highly skilled, engaged and resilient workforce based on a culture of collaboration, respect, integrity and accountability.

NALHN offers a range of primary health care services across the northern metropolitan area of Adelaide, with a focus on providing preventive and health promoting programs in the community, and transition and hospital substitution and avoidance programs targeted at chronic disease and frail aged.

Clinical leadership of care systems is central to the current national and state wide health reforms. NALHN care delivery is configured within clinical divisions that are patient-focused, clinically led groupings of services. - > Modbury Hospital is a 174-bed, acute care teaching hospital that provides inpatient, outpatient, emergency services, Aged Care, Rehabilitation and Palliative Care. GP Plus Health Care Centres and Super Clinics
- > Aboriginal Health Services
- > Mental Health Services (including two statewide services – Forensics and Older Persons)
- > Sub-acute Services

The total operating budget for 23/24 for NALHN is \$1.02 bn with a workforce of 4,710 FTE / 6,325 head count.
