Position Purpose

This position will provide expert environmental advice, project management and stakeholder liaison to support the delivery of complex environmental projects and initiatives.

As a Principal Environment Officer - Projects you will:

- Act as a technical expert, providing leadership and direction to team members to support the delivery of highly complex environmental and/or site restoration projects.
- Lead the delivery of assigned environmental projects including managing project teams, external consultants, and contractors.
- Provide specialist technical advice and evaluation of complex environmental matters.
- Develop and implement environmental projects and programs that promote positive outcomes, offset environmental impacts and address community concerns.
- Identify and manage legislative compliance obligations and approval processes for assigned projects and programs that trigger assessment and/or approval.
- Provide timely reports and advice on project delivery to project stakeholders and identify environmental risks and issues which may impact successful project completion.
- Facilitate project-based community consultation, including representing Council at a range of customer meetings, community and business forums.
- Develop team capability and drive a high performance, continuous improvement and customer focused team culture.
- Build high level relationships with a diverse range of internal and external stakeholders to ensure positive environment outcomes are achieved.
- Act as a department delegate and advocate on a variety of environment projects, providing a source of professional advice to key stakeholders.
