Overview of program

Cradle to Kinder (C2K) is whole of family service for highly vulnerable and at risk young families. The multidisciplinary service begins with antenatal support and may continue until the child reaches four years of age. The service is aimed to support young parents (under 25 years) where there are significant concerns for the unborn/new born. Priority access is given to young mothers who have been in the care system, Aboriginal women and women with a learning disability.

The aim of the service is to build the capacity of parents to provide for their children's health, safety and development. The aim is also to support the family's self-reliance and sustainability through access to education, training and employment. The focus of the service is intensive and specialised early parenting support alongside case work to address areas of vulnerability and risk.

The Outer-East C2K program covers the Knox, Maroondah and Yarra Ranges local government areas and is delivered by a consortium consisting of Anglicare Victoria (Lead Agency) and Mercy Health O'Connell Family Centre (OFC). Anglicare Victoria provides the function of key worker, who actively engages young parents and their children and provides a case work response. OFC provides ante and post-natal support and early parenting services.

C2K sits within the broader Family Services Program which includes Child FIRST, Family Services and a range of other parenting programs including Placement Prevention and Reunification. This position also supervises Family Services staff.

Position Objectives

1.	To co-ordinate the delivery of a high quality program that provides genuine and positive outcomes for clients.
2.	To work in conjunction with the Program Manager to plan and implement responses in relation to sector and service developments.
3.	To ensure appropriate processes are in place to enable continuous improvement of services and to promote best practice and ongoing quality improvement of the program.
4.	To ensure the program is operated in accordance with service and quality standards, program targets, DHHS & related service agreements, organisational policies and accepted standards of practice.
5.	To provide ongoing support, supervision, performance management, learning and development of team members in this program.

Key responsibilities

The key responsibilities are as follows but are not limited to:


1.	Ensure the delivery of program services meets client requirements and is in accordance with the service agreements and within program budget requirements.
2.	Monitor performance targets, outcomes, quality standards in service agreements, legislative and policy requirements, issues of quality of care issues, reportable conduct and complaints.
3.	Monitor program performance and outcomes through the collection and analysis of service data and implement changes to the operation of the program.
4.	Participate in the development and maintenance of quality partnerships with key agencies including the Victorian Government Department of Human Services (DHHS) and other community services providers.
5.	Participate in the professional development and recruitment of staff, including supporting a culture of reflective practice, quality supervision and coaching.
6.	Initiate and implement service improvements and participate in service redevelopment and redesign.
7.	Contribute to the preparation of the program budget and work with the Program Manager to maintain accountability for the program budget and implement corrective action as required.

Key Selection Criteria

The Key Selection Criteria are based on role specific requirements **and** the Anglicare Victoria Capability Framework. Applicants are required to provide a written response to **both** a) and b).

a) Role specific requirements

Applicants are required to provide a written response to the role specific requirements. The five criteria are to be addressed individually (no more than 2 pages in total).

 <p>Role Specific</p>	1. Tertiary qualifications, preferably in social work, psychology or behavioural sciences or equivalent.
	2. Excellent understanding of the Child Protection, OOHC placement and support services and family service system, including legislative and policy framework.
	3. Excellent knowledge of, and experience in the application of relevant theoretical approaches that underpin casework practice (including theories of child attachment, development and abuse) to vulnerable children, young people and families.
	4. Well-developed skills and experience in delivering programs and services within required timeframes and budget parameters.

Key Selection Criteria (continued)

b) Anglicare Victoria Capability Framework

Applicants are required to provide a written response to the Anglicare Victoria Capability Framework. Applicants are to describe how they demonstrate the characteristics in each of the three nominated capability groups; **Personal Qualities**, **Relationship and Outcomes**, and **Leading People** (no more than 1 page in total).

The Anglicare Victoria Capability Framework describes the capabilities required to meet the expectations of clients, colleagues and communities in today's changing environment.

These capabilities work together to provide an understanding of the knowledge, skills and abilities required of all employees.
