ROLE CONTEXT

Primary Objective(s) of role:

Employees classified at this level provide clinical nursing expertise, and/or provide clinical leadership for residential aged care (RAC) commonwealth funded sites in the area of Aged Care Funding Instrument (ACFI), Aged Care Assessment and Documentation. Employees classified at this level are experts within their area and stream of practice and have a significant degree of autonomy and decision making.

Various practice models may be used to enact this role, including but not limited to:

- Providing nursing care in the aged care environment
- Providing clinical leadership to nurses within the aged care environment
- Coordination and leadership of ACFI that contribute clinical expertise to improve care recipients outcomes
- Using clinical expertise and knowledge to ensure the correct level of ACFI is applied to the individual care recipients.
- To provide education and knowledge to nurses working within the aged care environment
- Ensure consistency across the South East region in regards to assessment packs and validation
- Develop sustainable systems to ensure the region meets financial targets
- Apply and share expert clinical knowledge to improve care recipients outcomes
- Increase the knowledge base and expertise of nurses and midwives in the area of aged care assessment and documentation and ACFI
- Undertake gap analysis for funding the ACFI claim
- Culture change for nurses and midwives in regards to the business practices and importance of ACFI claims
- Work in partnership with key stakeholders (external and internal) and work collaboratively with General Practitioners
- Ensure there is standardisation and compliance with documentation
- Contribute specific expertise to nurses within the aged care sector through clinical protocols and

- > The incumbent may be required to participate in Counter Disaster activities including attendance, as required, at training programs and exercises to develop the necessary skills required to participate in responses in the event of a disaster and/or major incident.
- > The incumbent may be required to undertake further study to obtain a qualification which supports the needs of the health units.
