### OVERVIEW OF RELEVANT AREA AND POSITION SUMMARY

UNSW Medicine is a national leader in learning, teaching and research, with close affiliations to a number of Australia's finest hospitals, research institutes and health care organisations. With a strong presence at UNSW Kensington campus, the faculty have staff and students in teaching hospitals in Sydney as well as regional and rural areas of NSW including Albury/Wodonga, Wagga Wagga, Coffs Harbour and Port Macquarie.

The Kirby Institute is a leading global research institute dedicated to the prevention and treatment of infectious diseases. Established in 1986 in response to the then emerging HIV epidemic, the Kirby Institute now contributes to knowledge on a broad range of diseases, including viral hepatitis and sexually transmissible infections. Focussing on the coordination of national surveillance programs, population health and epidemiological research, clinical and behavioural research and clinical trials, the Kirby Institute's research projects are conducted in partnership with communities most affected by epidemics.

The Kirby Institute aims to find ways to control infections, develop new therapies and preventative vaccines, as well as providing critical leadership to decision makers in Australia and internationally on the most effective, efficient and sustainable strategies to address epidemics.

The Research Clinician is responsible for the management and site coordination of the ReINVEST study including patient management in designated NSW local government areas. The study management will be conducted through the Justice Health Research Program (JHRP). The position will involve direct contact with male offenders on a daily basis, as well as interaction with Legal Aid, Magistrates, Police, Private Legal Practitioners, Community Corrections Staff and Prosecutors. This position will cover outer Western Sydney, including Mount Druitt and surrounds. From time to time coverage may be required at Central Sydney Locations and on rare occasions the Central Coast.

The role of Research Clinician reports to the Clinical Coordinator and has no direct reports.

#### RESPONSIBILITIES

Specific responsibilities for this role include:

- Provide leadership of the ReINVEST study within designated NSW Community Correctional Centre(s) and NSW Local Courts, ensuring that all aspects of the study is conducted according to International Conference on Harmonisation Good Clinical Practice (ICH-GCP) requirements as defined by the NHMRC in the National Statement on Ethical Conduct in Research Involving Humans and the TGA Note for Guidance on Good Clinical Practice.
- Develop, plan and implement the study treatment phase at the correctional centres
- Plan and develop study-specific processes, documentation and resources
- Provide advice and direction for risk management quality and efficiency improvements in the study conduct in consultation with the project team Manage and adapt complex logistical arrangements as required including analysis of issues and problem solving on an ongoing basis
- Implement and design an communications plan, provide education to centre personnel where required and ensure relevant stakeholders are informed
- Ensure that data collection instruments are complete, accurate and ensure other staff on the study adhere to the study protocol at various clinics
- Actively contribute to team meetings and investigator meetings and perform any other duties as directed by the Supervisor.
- Review, study protocols, subject information and consent forms and submit variations to Human Research and Ethics Committees for approval
- Ensure oversight of the study databases and records and ensure data is correct and accurate

- Provide leadership to the study coordinator in the REINVEST study, assist with the site and support adherence and maintainence of study documentation
- Ensure data collection instruments are complete, blood samples are collected and adherence to on-site monitoring is abided to in all clinical sites
- Conduct patient assessment and monitoring in the community including comprehensive psychiatric assessment, physical examination (if suitably qualified) and completing all study tools.
- Ensure patient assessments are performed in accordance to the study International Conference on Harmonisation - Good Clinical Practice (ICH GCP) requirements and study protocols as defined by the relevant standard operating procedures.
- Cooperate with all health and safety polices and procedures of the university and take all reasonable care to ensure that your actions or omissions do not impact on the health and safety of yourself or others

#### **SELECTION CRITERIA**

- Relevant Qualifications as a Registered Nurse, Registered Psychologist, or Clinical Psychologist with a current licence to practice from the Australian Health Practitioners Regulation Agency (AHPRA) with minimum five years post graduate experience in mental health
- Extensive knowledge in the application of Good Clinical Research Practice Guidelines and a demonstrated ability to implement and adhere to
- Proven clinical leadership skills and an ability to work collaboratively within a multidisciplinary framework
- Proven experience in conducting clinical research and demonstrated experience in screening and clinical management of offender
- Solid experience in planning and implementing improvements which increases quality and efficiency in clinical and research outcomes
- Proven experience in working in community correctional facilities and NSW Local Courts or in a similar challenging setting
- Clinical experience with violent offenders or aggressive clients with proven clinical assessment skills, with a track record of comprehensive mental state examinations
- An understanding of psychometric tools used to assess impulsivity and personality disorders and knowledge of Good Clinical Research Practice Guidelines (ICH-GCP)
- Capacity to undertake physical examinations (nursing), collect pathology samples or willingness to learn
- Ability to attend clinics situated in the Sydney outer western metropolitan area. Including the Downing Centre Local Court and, where required, the Central Coast
- Excellent organisational skills with proven capacity to work independently and meet deadlines with
  excellent communication and interpersonal skills including the ability to liaise with people from diverse
  backgrounds at all levels
- Knowledge of health and safety responsibilities and commitment to attending relevant health and safety training.
