Organisational Context

Organisational Overview:

Our mission at SA Health is to lead and deliver a comprehensive and sustainable health system that aims to ensure healthier, longer and better lives for all South Australians. We will achieve our objectives by strengthening primary health care, enhancing hospital care, reforming mental health care and improving the health of Aboriginal people.

SA Health is committed to a health system that produces positive health outcomes by focusing on health promotion, illness prevention and early intervention. We will work with other government agencies and the community to address the environmental, socioeconomic, biological and behavioural determinants of health, and to achieve equitable health outcomes for all South Australians

Our Legal Entities:

SA Health is the brand name for the health portfolio of services and agencies responsible to the Minister for Health and Ageing and the Minister for Mental Health and Substance Abuse.

The legal entities include but are not limited to Department for Health and Ageing, Central Adelaide Local Health Network, Northern Adelaide Local Health Network, Southern Adelaide Local Health Network, Women's and Children's Health Network, SA Ambulance Service, and six regional Local Health Networks including:

- Eyre Far North Local Health Network
- Flinders Upper North Local Health Network
- Limestone Coast Local Health Network
- Riverland Mallee Coorong Local Health Network
- Yorke and Northern Local Health Network

SA Health Challenges:

The health system is facing the challenges of an ageing population, increased incidence of chronic disease, workforce shortages, and ageing infrastructure. The SA Health Care Plan has been developed to meet these challenges and ensure South Australian's have access to the best available health care in hospitals, health care centres and through GPs and other providers.

Barossa Hills Fleurieu Local Health Network (LHN):

The Barossa Hills Fleurieu Local Health Network consists of four large casemix funded sites, a number of smaller, grant funded sites and a range of community based facilities.

The Gawler Health Service is a larger regional health unit and provides emergency care, inpatient care by local general practitioners (for adults and children), specialist surgical, chemotherapy and renal dialysis, outpatients, and maternal and neonatal. There are service links in place with Lyell McEwin Health Service.

The Barossa Health Service, includes both Angaston District Hospital and Tanunda War Memorial Hospital sites. Services include emergency, acute inpatient care by local general practitioners (for adults and children), specialist surgical, outpatients, and maternal and neonatal (Tanunda War Memorial Hospital only).

Mount Barker District Soldier's Memorial Hospital provides services within the Adelaide Hills, including emergency, acute inpatient care, specialist surgical, chemotherapy, maternal and neonatal and outpatient services.

The Southern Fleurieu Health Service in Victor Harbor provides services to residents of the Fleurieu Peninsula, including emergency and inpatient medical care by salaried medical staff, specialist surgical services and obstetric care provided by local medical practitioners. There is a chemotherapy unit and renal dialysis. The Victor Harbor Private Hospital is co-located on site.

Kangaroo Island Health Service, as a remote health unit, provides services including emergency, acute inpatient, surgical, maternal and neonatal and outpatient services. Kangaroo Island is a Multi-Purpose Services site and provides emergency, inpatient care, aged care and community care.

Kapunda Hospital provides services including emergency, acute inpatient, surgical, maternal and neonatal and outpatient services.

Emergency, inpatient care, outpatient services and aged care are provided at the Gumeracha District Soldiers' Memorial Hospital, Eudunda Hospital, Strathalbyn and District Health Service and Mount Pleasant District Hospital.

Residential aged care services including respite and daycentre activities are provided at Eudunda, Gumeracha, Kangaroo Island, Kapunda, Mt Pleasant and Strathalbyn.

Mental Health services include regionally-based Community Mental Health Teams. These are teams based at Mount Barker, Victor Harbor, Barossa/Gawler, Kangaroo Island and the Statewide Borderline Personality Disorder BPD Service.

The Rural and Remote Mental Health Service at Glenside, Adelaide, provides services to the region with a team including psychiatrists, psychologists, social workers, occupational therapists and mental health nurses. There are also specialist youth mental health clinicians and access to specialist older persons mental health services.

Services are also delivered using the Distance Consultation and Liaison Service, which includes the Emergency Triage and Liaison Service (ETLS), Older Persons Consultation Liaison Service and Tele-Psychiatry.

The LHN provides a range of Aboriginal health services such as the Aboriginal Family Birthing Program in Gawler.
