

The Clinics will maximise the opportunity for students to undertake clinical experience necessary to meet their educational and professional requirements and will foster strong professional and community support. Charles Sturt University offers private dentistry and student dental clinics to the general public. The Clinics are run by the Faculty of Science in support of the School of Dentistry and Health Sciences.

Position overview

To assist and provide quality clinical and professional support to oral health clinicians, teaching staff and dentistry students in the performance of their tasks within both academic and commercial clinical environments.





Principal responsibilities

Patient Care

- Provide a high standard of dental assisting to the clinician to whom you are rostered.
- Comply with Charles Sturt University Dental and Oral Health Clinic Policies and Guidelines relevant to the provision of patient care.
- Prepare all equipment, instruments and materials for each patient procedure.
- Assist the clinician in the management of patient treatment, including evacuation and instrument transfer.
- Assist the clinician in the management of the patient's well being during clinical procedures.
- Process intra-oral radiographs.
- Assist the clinician in the documentation of patient treatment, both in written form and utilising the electronic Patient Management System, including charting, as requested.
- Decontaminate the clinical bay and reusable equipment at the end of each appointment and appropriately prepare instruments for decontamination / sterilisation.
- Clean, pack and sterilise instruments in accordance with Charles Sturt University Dental and Oral Health Clinic procedures for sterilisation.
- Assist with the maintenance of instruments and equipment within the clinics.
- Assist in the education of patients in dental health care when requested by the clinician.
- Liaise with the dental laboratory staff for receiving, preparing and dispatching of clinicians' laboratory work.

Infection Control:

- Maintain a high standard of infection control in accordance with the Charles Sturt University Dental and Oral Health Clinic Infection Control Policy and Sterilisation Room Procedures.
- Comply with the need for and documentation of vaccination against infectious diseases.
- Be aware of your blood borne virus status through annual serology testing and testing in the event of exposure.

Communications:

- Treat patients and other staff with courtesy and respect at all times.
- Demonstrate good communication skills with patients and other members of staff.

Administrative Duties:

• Provide reception relief as required.





Training and Continuing Education:

- Ensure your dental assisting knowledge is current.
- Assist with the orientation of all new employees, when required.

General Duties:

• Perform other duties as directed by the Senior Dental Assistant or Clinical Director, appropriate to your classification, as required.

Physical capabilities

Selection criteria

Applicants are expected to address the selection criteria when applying for this position.

Essential

- A. Completion of Certificate III in Dental Assisting or at least 4 years' demonstrated experience in dental assisting, or an equivalent level of knowledge gained through any other combination of education, training and/or experience.
- B. Demonstrated sound dental assisting skills and understanding of infection control in the dental environment.
- C. Excellent oral and written communication skills and a demonstrated ability to liaise effectively with a range of individuals, including the general public, whilst always maintaining privacy and confidentiality in line with relevant legislative requirements.
- D. Good organisational skills and a demonstrated ability to use initiative.
- E. Commitment to continuing professional development.
- F. Demonstrated experience with using Windows based software.
- G. Current NSW driver's license.

Desirable

H. Completion of or evidence of progression towards Certificate IV in Radiography or Oral Health or Certificate III in Sterilisation.
