POSITION SUMMARY

This role is responsible for delivering the Aboriginal-led Case Conferencing (ALCC) program, alongside the existing ALCC Convenor in VACCA South. The ALCC is an early intervention program designed to divert Aboriginal families away from the Child Protection system and into culturally safe supports.

The ALCC Convenor is referred Aboriginal families, including those expecting a baby, who have been reported to Child Protection. The ALCC Convenor meets with families, helps to connect them with culturally safe services and facilitates Aboriginal-led case conference meetings which aim to support families to address child safety concerns.

POSITION ACCOUNTABILITIES

As the Aboriginal-led Case Conferencing Convenor, your role will involve:

- Working with Aboriginal families, children, and young people (including mothers pregnant with an Aboriginal child) referred by Child Protection
- Engaging with families and speaking openly about why a Child Protection report has been made and informing them of the process and positive outcomes of engaging with the ALCC program.
- Identifying and making referrals to relevant internal and external support services
- Coordinating and chairing ALCC meetings with family members, extended family, Elders/respected persons, significant others in the child's life, key workers/professionals from relevant programs
- Working collaboratively with other VACCA programs, external service providers and Child Protection
- Where appropriate, seeking risk-based consultations with Child Protection
- Undertaking short-term case management support while families wait to be connected to services and ensuring that they're well-supported before closing.
- Attending and engaging in ALCC Local Operations Group meetings with Child Protection, internal meetings relating to VACCA's CP Reform Implementation project, and other relevant meetings
