- Lead the development, implementation and monitoring of the Australian Performing Arts Collection's collection development strategy with a focus on a strategic and sustainable acquisition program to meet community expectations
- Champion fresh thinking and approaches to the performing arts and arts and design and seize
 opportunities to be creative, experimental and innovative
- In conjunction with the Director and Head of Collections Management, Preservation & Access, work with curators to propose and develop high quality and engaging cross-platform ideas and experiences from conception to delivery including publications and public programmes
- Serve as the overall content authority for cross platform content development ensuring the balance of scholarship and value for audiences
- Work closely and strategically with internal stakeholders such as External Engagement,
 Communications and Arts Learning on the curatorial team's contribution and on developing the national remit of Arts Centre Melbourne's curatorial experts
- Cultivate relationships with donors, supporters and the broader sector to support the Australian Performing Arts Collection's artistic program through gifts, purchases and fundraising efforts
